### PRE-ESTIMATED FEE

The exact quantities of the works pertaining to the geological and geotechnical surveys cannot be pre-estimated as accurately as needed, due to the nature of these very works (investigation works in rather unknown sub-soil) and to the fact that the alignments have not yet been finalized.

Therefore, the cost for these required surveys is pre-estimated based on AM's available data without any breakdown to physical scope units.

Based on AM's relevant available data regarding geological and geotechnical surveys and designs in the Athens Metro Extensions and by means of prices actualization, it is estimated that the overall pre-estimated fee for the geological and geotechnical surveys and designs to be awarded shall be as follows:

The pre-estimated fee shall also include a portion based on the Service's estimates. This fee shall concern the works of the Service's Price List items A.19 and B.146 - B.164. The portion of the pre-estimated fee to derive from the Service's estimates, based on the above items, is very small and, thus, smaller than the portion of the pre-estimated fee to derive upon application of the Regulations.
